

## Copyright for theses

### Open Access

Making your thesis open access increases its visibility and readership and enables other researchers to build on your research. As detailed in the [Code of Practice for the Conduct of Postgraduate Research Degree Programmes](#) theses will be made open access under a Creative Commons licence. Theses will be licensed under a [Creative Commons Attribution 4.0 International Licence \(CC BY\)](#) unless you select an alternative Creative Commons licence at the point of deposit. Once a thesis has been made open access under a Creative Commons licence the terms of that licence cannot be revoked.

You will select your licence when you deposit your thesis for submission in USIR via Worktribe. Guidance on depositing your thesis is available on the [Doctoral School Hub](#). By depositing in USIR via Worktribe you are agreeing to the [USIR deposit agreement](#).

## Choosing a Creative Commons licence for your thesis

[Creative Commons Licences](#) enable researchers to retain control over how their research is used and ensures that they are given credit for their work in any future adaptations or use. Authors should consider whether they need to select a licence which restricts commercial reuse or adaptations of their work.

## Will depositing my thesis affect my copyright?

Publishers do not normally consider the publication of an academic thesis in an institutional repository to be “prior publication”, nor do they normally restrict an author’s right to include their own published work in an academic thesis. However, students are advised to check publisher copyright policies.

## Restricting access to your thesis

Normally, a thesis is made live and publicly accessible immediately after graduation, but, if necessary, you can apply for a moratorium (embargo). If granted, access will be restricted for two years. After that period, annual extensions will be considered up to five years in total. If you wish to apply for a moratorium, contact the University’s Postgraduate Administration team [sa-pgr@salford.ac.uk](mailto:sa-pgr@salford.ac.uk)

## Using third party copyright material

“Fair dealing” allows the use of copyrighted material for the purposes of study, research and examination, so as a research student, you can use this material in your thesis without infringing copyright. However, by [depositing an electronic copy in USIR](#) you are effectively making someone else’s intellectual property freely available online – and it may be necessary for you to seek copyright permission.

Our [Copyright for researchers](#) interactive tool will help you determine whether you can use specific types of copyrighted material for your research and what you are allowed to do with them.

Some sites, for example [Biorender](#), will only allow licensed content to be used in an online thesis. If you are unsure of permissions, contact [library-research@salford.ac.uk](mailto:library-research@salford.ac.uk) for advice.

## Obtaining third party copyright material

**I am a PhD [or appropriate degree] Candidate at the University of Salford.**

**I am contacting you to seek permission to include the following material within my thesis: [Provide as much detail as you can about what it is you wish to use, for example, author, date, title, journal title, page numbers, description if it is an image, etc.]**

**Following completion of my degree I will make my thesis electronically available in the University of Salford's Institutional Repository, USIR: <http://usir.salford.ac.uk/>. USIR is an open access, non-commercial repository.**

**If you are not the rights holder for this material, I would be grateful if you would advise me who to contact.**

Obtain copyright permission for any third-party material as soon as you decide you want to use the material. To seek copyright permission, you must contact the *rights holder*. This might be an author, illustrator, composer, etc., or the publisher. Below is an example of the wording you might use.

Do not expect an immediate response. If you have heard nothing after about six weeks you should write again. Keep a copy of any letters or emails you receive. If copyright permission is granted, indicate that copyright permission has been granted at the appropriate place in your thesis. If copyright permission is refused or you receive no response, you will not be able to use the copyrighted material in an electronic version of your thesis and you must still submit your complete thesis in USIR, along with an edited or redacted version.

## PhD by Published Works

If you are completing a PhD by published works you should include your works in your thesis, but you may need to apply for copyright permission to include papers in the accessible USIR version. If the work has been published open access with a [creative commons license](#) you do not need to apply for permission and can use the published version of the record. If the publication is not open access, most journals will allow inclusion of the accepted version of the article. If permission to include the works is not granted, an edited (redacted) version should be created: replace the outputs with their citations and include links to the published and open access versions, where available.

Save a copy of the final passed version of your thesis with all corrections, copyright-restricted or confidential material included. Replace any content which can be made public with a placeholder stating the reason for its removal, Retain any captions and upload both versions to USIR.
